



**ATOMIC DUCKS DIVE CLUB  
LIABILITY RELEASE AND ASSUMPTION OF RISK**

**Please read carefully before signing.**

- I am a certified scuba diver, trained in safe diving practices.
- I understand and agree that neither ATOMIC DUCKS DIVE CLUB, nor its sponsors, representatives, officers, agents, or assigns (hereinafter referred to as “Released Parties”), may be held liable or responsible in any way for any injury, death or other damages to me or my family, heirs, or assigns that may occur as a result of my participation in a diving activity, or as a result of the negligence of any party, including the Released Parties, whether passive or active.
- I further save and hold harmless all Released Parties from any claim or lawsuit by me, my family, estate, heirs, or assigns, arising out of my participation in a diving activity, including both claims arising during the activity or after I complete the activity.
- In consideration of being allowed to participate in a diving activity, I hereby personally assume all risks in connection with the dive(s) for any harm, injury or damage that may befall me while I am a participant, including all risks connected therewith, whether foreseen or unforeseen.
- I understand that scuba diving involves certain inherent risks. Decompression sickness, embolism, or other hyperbaric injuries can occur. These injuries may require treatment in a recompression chamber. I further understand that a diving activity may be conducted at a site that is remote, either by time or distance or both, from such a recompression chamber.
- I declare that I am in good mental and physical fitness for diving, and that I will not dive under the influence of alcohol or under the influence of any drugs that are contra indicatory to diving. If I am taking medication, I declare that I have seen a physician and have approval to dive while under the influence of the medication/drugs.
- I understand that scuba diving is a physically strenuous activity. I will be exerting myself during diving and if I am injured as a result of heart attack, panic, uncontrolled ascents, exceeding decompression limits, etc., I assume the risk of said injuries and I will not hold the Released Parties responsible for the same.
- I will inspect all of my equipment prior to diving to insure that it is in safe working condition and appropriate for the dive.
- I further declare that I am of lawful age and legally competent to sign this liability release, or that I have acquired the written consent of my parent or guardian.
- I understand that the terms herein are contractual and not a mere recital and that I have signed this document of my own free act.
- As a responsible diver, I will dive with a buddy on all Club dives.

**I declare that I will assess the risk of any Club dive and will assume all responsibility for my safety. I have fully informed myself of all of the contents of this Liability Release and Assumption of Risk by reading it before I signed it on behalf of my heirs and myself.**
